### Artistasalon Rules and Agreements:

1. All attempts to honor requests for particular table locations will be made. Artistaconcepts LLC offers no guarantee and changes may be made at their discretion.
2. There is one six-foot (6') table allocated for each Exhibitor. Please be considerate of your neighbor's space. Please do not allow the contents of your booth to occupy that of your neighbors. All backboards must be freestanding, no higher than 6 feet, and the leg width may not be greater than two feet deep or 6 feet wide when in use. All tables must have a fabric table cloth. Color or logos are up to the Exhibitor. Exhibitors will not nail, screw, pin and/or attach anything to the tables, chairs, drapes, table coverings and/or any portion of the venue.
3. Table reservations may be canceled up to March 20th, 2019. Failure to attend will result in forfeiture of your space and a ban from displaying at future events
4. Set-up and Breakdown: Set-up will begin Saturday, March 23rd, at 6:00 pm. Exhibitor will be given floor plans and table assignments upon registration on March 23rd, 2019. Table set-up must be completed by 6:50 pm. Table breakdown will begin at 11:00 pm on Saturday, March 23rd. Exhibitor must vacate the premises no later than 11:30 pm. Table breakdown will not begin before the end of the show.
5. Each vendor is responsible for complying with all NJ and PA Sales Tax Laws concerning licensing and the collection of appropriate sales tax.
6. Dealers must comply with all copyright and trademark laws as applicable. Anyone caught selling items of an illegal nature, including but not limited to bootleg videos, DVD, Blu-Ray, and other media, will be asked to leave the Artistacon and Artistasalon and may be barred from displaying at future events.

8. Vendors will be given one 2-Day All Inclusive Pass per booth. Additional badges may be purchased at \$60 each and a total of 2 extra badges. Artistaconcepts LLC reserves the right to refuse the purchase of additional badges.

Vendor and/or exhibitor will not be allowed to set up or exhibit until this document has been received and approved by an approved agent of Artistaconcepts LLC
